Tenant agrees to park his RV at his own risk.
- F. The indemnity set forth above shall apply to attorney's fees and other costs of defense and in the event that any suit shall be brought by Association or tenant against the other arising out of this agreement, the prevailing parties shall be entitled to attorney's fees and costs in a reasonable amount as determined by the court.
- G. This agreement shall be binding on and inure to the benefit of the heirs, assigns, and personal representatives of the parties.

## H. Rules:

- 1. No maintenance is to be performed on any vehicle, except washing is permitted.
- 2. The RV storage area is for the purpose of storage only and for no other use.
- 3. Failure to pay the Association the monthly fee will result in the Association towing away the vehicle at the owner's expense.
